

One Third of Our Gifts for the Poor

When I lived and worked in the Islamic countries of Bangladesh and Mauritania, they had two Eid festivals each year. They were roughly equivalent to our Christmas and Easter in terms of their importance- with gifts of clothes and exceptional feasts of food.

But they had a very practical rule to keep everything in perspective. One third of the gifts were reserved for the larger extended family, one third was to be shared with friends(peers), and one third was to be shared with the poor. I was impressed that they were ready to share so much with the poor.

As we prepare to share our bounty of gifts and food with family and friends in the Christmas Season, may I invite you to focus one third of your gifts on the poor. No I am not talking of tithing 10% of our Christmas gifts for the poor, but 33% of your gifts.

Oh, by the way, if you have trouble identifying who is poor, you might let the ELCA help you decide.

You could start with ELCA Good Gifts Catalogue.

Or you could consider the victims of SuperStorm Sandy in Haiti and along the East Coast of the USA, which I regard as the new poor. You could find their address at ELCA Disaster Response.

Or you could consider the 165 million under five children who are chronically undernourished, and the 2.6 million under five children dying each year from hunger. You could find some of them at the ELCA World Hunger Fund.

Or you could consider the 900 million people without clean water, and the 2.6 million under five children dying from diarrheas and dehydration. You can help fund water wells through ELCA World Hunger.

Or you might consider many people suffering and dying from Malaria, about 600,000 deaths are African under five kids. You can give to the ELCA Malaria Campaign, which is helping 11 African Lutheran churches.

Or you might consider the 22 million Africans who are suffering with HIV AIDS. Through ELCA World Hunger, we are assisting many African churches as they train hospice volunteers and other groups to do education and outreach to begin services for the many AIDS sufferers and the 16.6 AIDS orphans.

Or you might consider Lutheran Social Services as they provide services to troubled youth, half way houses for the people recovering from addictions, and half way houses for newly released prisoners. LSS has been a very consistent church and state partner.

Or you might consider a larger donation to your local food pantry or the Salvation Army.

The exciting thing is that these church agencies can function well with administrative and PR costs of 6 to 8 percent. So we can be proud of the efficiency of our organizations. They know where to find the poor, and they can deliver at reasonable cost.

World AIDS Day 2012 Celebrated in Many Lutheran Churches December 2nd

We have some things to celebrate this year. UNAIDS representing the UN agencies, has reported that about 50% of AIDS sufferers are receiving the anti-retro-viral drugs that they need. Eight million people are receiving ARVs. President Bush's dream in 2003 is becoming a reality. You must see the "Lazarus Effect" 30 minutes movie to actually see and believe that the ARVs can be so successful. The parents return to health and take care of their families.

Parents everywhere are getting excited to know that babies of HIV+ mothers have almost a 100% chance of being HIV free. If only the HIV+ pregnant mother is treated with ARVs and the new born is given a combo ARV at birth.

African countries vary widely in delivery of services for mothers during pregnancy. Some countries offer their mothers good coverage of say 70 to 80% of pre-birth services, while the coverage of these HIV ARVs may or may not be offered to these same mothers. The ARV treatment for new born children as prevention often is lagging. There are some countries where only 1% of the babies receive their ARV preventive treatment. There are others where the ARV coverage of newborns is between 60 and 80%. Average new born treatment coverage is closer to 50%.

The challenge of the churches and the health facilities is take this new hope to every village. It is important for mothers to know their HIV status ahead of the birthing time: to prepare the mother with some ARV medications, and to give the child of the HIV+ mother the combo ARV shot immediately after birth.

Some 34.2 million people live with AIDS in 2011. AIDS deaths have fallen to 1.7 million in 2011 from 2.3 million deaths in 2005, which is a decline of 24%. Tuberculosis has become a prime killer of AIDS patients; therefore World Health Organization recommends that AIDS and TB be treated together by the same medical team. ELCA has been supporting AIDS education as well as hospice programs for a number of years in collaboration with African churches.

- December 2, 2012 is the Sunday when most Lutheran churches acknowledge World AIDS Day. After Worship service, during fellowship time Pastor Chuck will show the ELCA HIV AIDS Campaign video in the Fellowship Hall.
- The Council approved the online version of Sundays and Seasons be purchased. This will change the bulletin and be easier for people to follow along including visitors. The Psalms will be included in the bulletin so there will be no need to purchase the Celebrate insert. The new bulletin will start the first Sunday in Advent.
- The Council approved the purchase of a new projection screen for fellowship hall, using undesignated funds from the Memorial Fund.
- Christmas Eve Services will be a Candlelight Service at 7:00 p.m. on Monday December 24, 2012.
